**ORDER OF EXCLUSION**

9 THIS MATTER having come before the undersigned judge on the agreement of the parties, and the  
10 court being fully advised in the premises, now

11 HEREBY ORDERS pursuant to LCL 5.11.100 and 12.03.040 that the defendant is excluded from  
12 the Lummi Reservation for a MINIMUM PERIOD OF FOUR YEARS FROM THE DATE OF THIS  
13 ORDER UNTIL FURTHER ORDER OF THE COURT. The defendant may apply to the court for  
14 readmission after that period of time, and will be readmitted if he demonstrates to the court at that time that:

- 15 1) he has committed no criminal offenses for the four years immediately prior to readmission;
- 16 2) he has had a substance abuse evaluation within the prior two years, has complied with any  
17 recommendations, and can document sobriety for the one year immediately prior to readmission through  
18 random supervised testing;
- 19 3) he has received a mental health evaluation within the prior two years, has complied with any  
20 recommendations, and he is taking any medication on the prescribed schedule; and
- 21 4) he has received a batterer's evaluation and has complied with any treatment recommendations.

22 IT IS FURTHER ORDERED that, as part of petitioning the Court for readmission, the defendant  
23 must execute releases of information allowing the Lummi Nation to obtain records and consult with the  
24 defendant's

- 25 1) probation officers as to the defendant's compliance with terms of probation or a deferred  
prosecution;
- 2) treatment providers for substance abuse, mental health, and batterer's treatment as to the  
assessments conducted, nature of the treatment provided, compliance with treatment recommendations, and  
discharge documentation; and
- 3) substance testers as to the nature of random testing provided, substances for which the samples  
are being tested, and the results of that testing, including positive results, failures to appear for testing,  
refusal to submit to testing, attempts to submit false samples, and results showing dilute.

IT IS FURTHER ORDERED that upon readmission to the reservation, the defendant will be  
placed for five years on a contingent order of exclusion allowing him reentry on the reservation as long as  
he complies with the following requirements:

- 1) Must report at least one time a month to the Lummi Probation Office, or more frequently as  
directed by the probation officer;
- 2) May not commit any criminal law violations;
- 2) May not be knowingly present where drugs are being illegally sold or used;
- 3) Must be employed, actively seeking employment, performing full-time child-care, attending  
school, participating in vocational training, or in residential treatment;

*Order Prohibiting Contact*

1 4) Must abstain from alcohol and non-prescribed drugs; must submit to a random urine analysis  
2 and portable breath test(s) on a schedule determined by the probation officer; and must submit to a portable  
3 breath test by a police officer who has reasonable basis to believe defendant has consumed alcohol; and

4 5) Must comply with mental health provider's treatment plan, including taking any medication on  
5 the prescribed schedule.

6 If Court determines by the preponderance of the evidence that the defendant failed to comply with the  
7 conditions of the contingent order of exclusion, the defendant will again be excluded from all areas within  
8 the exterior boundaries of the Lummi Reservation.

9 **VIOLATION OF THIS ORDER IS A CRIMINAL OFFENSE UNDER THE LUMMI CODE OF LAWS ,**  
10 **CHAPTER 5.07.075 AND WILL SUBJECT THE VIOLATOR TO ARREST AND A CRIMINAL PENALTY**  
11 **NOT TO EXCEED ONE YEAR IN JAIL AND A \$5,000 FINE.**

12 Notice: To the Chief of Lummi Police:

13 YOU ARE HEREBY DIRECTED to maintain a record of this Order and its provisions. YOU ARE  
14 FURTHER DIRECTED TO ARREST AND DETAIN THE DEFENDANT if the defendant violates the terms of this  
15 Order
